who supplied milk plants regulated under the New York-New Jersey marketing orders during April 1987 will be paid on the basis of a uniform price of \$11.55 per hundredweight, 24.8 cents per quart; the price for the corresponding month last year was \$11.31 per hundredweight. Market Administrator Thomas A. Wilson also stated that the price was \$11.92 in March 1987. The uniform price is a marketwide weighted average of the value of farm milk used for fluid and manufactured dairy products.




