

Liberty Valley Joins United Dairy

SYRACUSE, N.Y. — Members of Liberty Valley Cooperative Milk Producers Association Inc. of Liberty Valley, Pa., have recently reorganized and have joined United Dairy Cooperative Service Inc. for assistance in improving marketing of their milk and participating in United's market-wide services. Their members will be shipping to Dietrich's Milk Products Inc. plant in Middlebury Center, Pa. United has been able to significantly increase the producer pay price above the minimum allowed by the Federal Milk Market Order, the price usually paid to farmers.

Producer price premiums, quality incentive bonus, and a bonus program for maintaining constant year round production, are programs initiated by United to

improve dairy farmer's income. These price premiums are combined with the most favorable hauling rates in the area.

United's President James G. Patsos stated that, "We are pleased with the confidence exhibited by Liberty Valley Cooperative members in joining our growing organization. United Dairy Cooperative Services Inc. is a bargaining cooperative whose main interest is to provide the best opportunities available for marketing our member's milk without being burdened with responsibility for plants and equipment that may prove costly to their members. United continues to provide legislative representation, economic and market information, and field services beneficial to all producers throughout the area."

Montgomery County Wins Dairy Bowl Contest

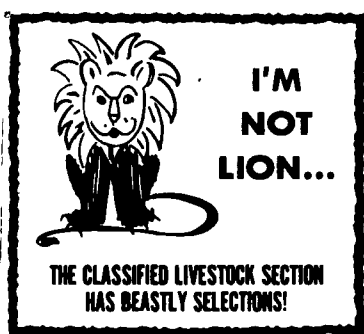
