"Dolly" owned by Queens-Manor, James Siedel and Donald Green, experienced a near miracle. Six weeks after calving she was down for six days. She has been up just three weeks and was scored 87 points on July 21st. "We're fortunate we didn't lose her," claimed

The first place four year old was given the honor by Judge Dave Bachman, national director of the Holstein Association in Sheboygen, Wisconsin. He is also the owner of Pinehurst and Lakehurst Holteins. Les Firth, Mercer County agent, said that Bachman praised the extreme high quality seen at this size of show.

Morrell Farms of Cochranton claimed reserve grand champion, aged cow, best three females and best bred and owned classes to garner premier breeder honors. Bob Morrell explained that the first


