

Southeast 4-H Dairy Show

Over 160 dairy animals represented eight counties in the 42nd Annual Southeast 4-H Dairy Show at the Kutztown Fairgrounds, Friday, August 21. According to the Holstein judge Leroy Plance from Wellsboro and Lori Sollenberger colored breeds judge from Everett, quality was represented in all breeds representing Berks, Bucks, Chester, Lehigh, Monroe, Montgomery, Northampton and Schuylkill counties.

Patricia Miller of Nazareth, Northampton took both grand champion and reserve grand champion in the Holstein division.

In the top spot was her 4-year-old M-Maplegrove Valiant Sibyl, sired by S-W-D Valiant. This animal also won best udder in her class. Taking the reserve spot was Miller's 3-year-old, M-Maplegrove Es Mysticle-ET, sired by Thonyma East Star-Twin which was also selected as having the best udder in her class.

Taking the junior champion in the Holstein class was Jeffrey Davis' entry, an intermediate yearling, Danview Pete Ginger from Leesport, Berks County. In the reserve champion position was Craig Walton of Newton in Bucks County with his senior calf, Fountain Farm Pete Jingle-ET.

Troy Henricks of Phoenixville in Chester County took the grand champion honors in the Jersey breed. His senior 2-year-old, Top-O-Hill Silver Beacon Twinkle was sired by Valley Stream Silver Beacon. Karen Sanner's Junior 2-year-old took the reserve spot. Top-O-Hill Silver Beacon Penny was sired by Valleystream Silver Beacon. Junior champion went to an entry from Toughkenamon, Chester County, belonging to Jennifer Lamborn, a junior yearling, CLV Milestone Hollywood Reserve junior champion in the Jersey division went to Owen Bewley of West Chester, Chester County, with his entry in the junior calf class, Top-O-Hill Super C Trix.

In the Ayrshire division the grand champion title went to Mark Price of Douglassville in Berks County with his 4-year-old Conabella HC Petulia sired by Sycamore Meade Hi Champ. Reserve champion went to Amy Wolf-

gang's entry from Gilbertsville in Montgomery County. The junior two-year-old, Eureka Classic Boy Primrose was sired by Ardrossan Bellevilles CL Boy. Junior champion went to Kelly Young with Timberlawn Squire's D R Baby and reserve champion went to Charles Young's entry—Timberlawn Hi Champs Rose Anne. Both entries were from West Grove in Chester County.

Clayton Snyder's 3-year-old Guernsey chosen as having the best udder took grand champion. The winner was Snyders Favor
