## New Zealand Lamb Imports Temporarily Stalled

DENVER, Co. - New procedures governing the importation of livestock into the United States have been issued by USDA, temporarily stalling the further importation of New Zealand live lambs into the U.S.

Sheep producers are being strongly urged by the National Wool Growers Association to make formal written comments on the proposal. All written comments are due by April 1.

The new regulations update existing rules, some up to 50 years old. USDA-Animal Plant Health Inspection Service proposed the changes following growing interest from New Zealand in importing large numbers of sheep into the U.S. Anticipated imports of sheep would overload federal livestock quarantine facilities under current regulations.

Although USDA considers the rule changes minor, changes could have a major impact on the domestic livestock industry.

Regulations call for the additon of requirements for approval of privately operated quarantine facilites for imported sheep. Currently, only federal facilities can be used for quarantine. Facilities would have to be properly located and equipped to prevent the spread of communicable diseases.

Health certification provisions help ensure that sheep entering the U.S. are disease free, to prevent the spread of new strains of disease in domestic flocks. NWGA has raised questions of the feasibility of testing for some strains of disease and the possibility of transmission of diseases to the domestic flock.

In addition, the regulations specify that sheep entering privatelyoperated quarantine facilities in the U.S. be accepted only at ports where appropriate federal personnel are available to screen the animals.

NWGA is urging USDA to hold congressional hearings on the proposed regulations to allow adequate producer and industry input into the important rules. USDA has stated further permits on the importation of live lambs will be postponed until the new regulations are adopted. A shipment of 10,000 New Zealand wethers is pending release from quarantine in Portland. They were the first shipment of feeder lambs to be imported into the U.S.


Two public hearings on the regulations will be held March 15 at City Hall, City Council Chambers,
