## Dairy Promotion Group Seeks Board Members

HARRISBURG — "Dairymen who love a challenge, we have one for you," announced Jim Harteis, Ebensburg dairy farmer and Board Chairman of the Pennsylvania Dairy Promotion Program.

The PA Department of Agriculture is looking for men and women to serve on the Board of the Pennsylvania Dairy Promotion Program. Board members must be working dairy men/women or be an employee of a dairy farm. In addition, each member must contribute 10-cents per hundred weight of promotion assessment to

the Pennsylvania Dairy Promotion Program. All Board members are expected to be active, and will be appointed to the Board by the Secretary of Agriculture, Boyd E. Wolff.

Secretary Wolff explained that over the past year, the Board has gone from an Advisory Board to a Board with direct authority. This change was made possible when Governor Casey signed ACT I of 1987 into law, returning control of Commodity Marketing Programs to farmers. "This Act frees farm commodity groups from most state

operating procedures," stated Secretary Wolff.

"In other words, we call our own shots and control our destiny," said Jim Harteis. The Department of Agriculture has taken on the role of advisor.

"With the expanded authority, this program has become a real challenge. We owe it to the Pennsylvania dairy farmers to find the best people possible to serve as Board members. These Board members will be responsible to the dairy industry in Pennsylvania to increase consumption of dairy products," explained Secretary Wolff.

Anyone interested in serving on the Board can be nominated by a dairy cooperative, a farm organization, or by an independent dairyman/woman who contribute to the program. All nominations must be submitted by August 15, 1988 to the Secretary of Agriculture, c/o The Pennsylvania Dairy Promotion Program, 2301 N. Cameron Street, Harrisburg, PA





been hired by Southeast Farm Credit Service as a Loan Officer in the Silverdale Branch; Branch Manager Dean Shollenberger announced the hiring.


Mrs. Barber is a graduate of State College (PA) High School and received a Bachelor of Science degree in horticulture/retail management from Penn State University in 1979.
