
Northeast Chicken Parts

Wednesday, February 15, 1989 Trading activity was light to fair with most buyers limiting receipts to an as needed basis; however, lighter than normal bird size has reduced overall production, and supplies of all but leg items were in tight supply. Demand for cutlets was no better than fair. Whole breasts remained short of full inquiry although most deboners were limiting receipt to standing commitments. Legs and leg quarters were featured this week at 39 to 69 cents throughout the area and most retailers showed little interest in features next week despite fully adequate offerings. Wings were tight for a irregular call.
