

Movement of ready to cook whole fryers was fairly good. Supplies continued short of current needs. In the parts complex, supplies of cutlets were adequate to instances fully adequate, whole breasts were barely adequate, legs and leg quarters were ample to instances surplus, while wings were short of needs. Less than trucklot asking prices were unchanged to higher at 68 - 80 cents. Live supplies were adequate. Average live weights ranged light to desirable. Today's slaughter schedules were moderate. The trade sentiment was fully steady to firm.

Trucklot buying interest was mixed and selective and centered mainly on heavy offerings of leg quarters at lower trending prices. Legs were also in heavy supply and difficult to clear at several points. Oxlets were adequate to fully adequate and prices held unchanged with spot discounting still a part of some trading. Whole breasts increased in availability and several buyers took a wait and see position; the bulk of new business was slow in developing; however, trading prices were generally weak and unsettled. Wings were in tight supply; demand fairly active.

The market tone was generally steady although underlying sentiment was becoming increasingly more cautious. Cartoned egg demand was irregular with retail promotional activity usually attracting the best interest.
