Cutlets were in best balance and generally adequate at unchanged prices; however, some forward pricing was noted at discounts to commercial quotes. Whole breasts, both line run and rib-on were slow in clearing and new sales were at lower prices. Legs and leg quarters remained ample, despite increased bookings for upcoming ad activity; some buyers noted a need to clear current heavy stocks of leg quarters prior to viewing new offerings. 
