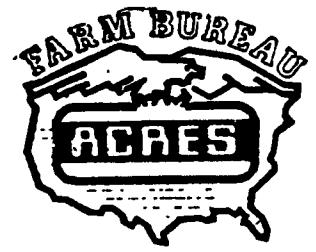

**Acres Hog Update:** Live hog futures prices closed mixed today with settlements from 30 lower on the February to 40 higher on the spot October. Front month support was tied to continued cash market firmness and active bull spreading with gains held in check by higher than expected interior receipts. Ideas that tomorrow's cash market would be steady to lower due to packer resistance at current levels served to temper gains. Profit-taking was also featured today with additional losses in the back months coming on active belly/hog spreading. Bellies were sharply higher on ideas that recent losses were overdone. October live hogs settled 40 higher at \$47.62 after trading in a range from \$47.25 to \$47.80.
