March 14, 1990 Movement of ready to cook whole fryers was only fair today. Some buyers have rescheduled or canceled regular commitments in an attempt to control floor stocks. Supplies were fully adequate. Less than trucklot asking prices were steady at 59-67 cents. Live supplies were adequate. Average weights were mostly desirable. Processing schedules were moderately heavy. The trade sentiment was barely steady. In the parts complex, supplies of wings were adequate and clearing, cutlets were somewhat irregular and ranged adequate to fully adequate, whole breasts, and the dark

Supplies were mostly in balance with needs and additional offerings were irregularly available but usually held with confidence. Breakers attempted to work as close with needs as possible with finished product sales slow and both end users and further processors reluctant to carry heavy inventories.
