

## Weiss Joins Farmland Trust

LANCASTER (Lancaster Co.) - Lancaster Farmland Trust, the non-profit farmland preservation group, announced today that Karen M. Weiss will be joining its staff to fill the organization's new Land Conservancy position. Made possible through a grant from the William Penn Foundation in Philadelphia, the position will involve meeting with land owners to work on agricultural land preservation goals, assisting with negotiations involving creative conservation land acquisitions, and maintaining the Trust's Farmland Registry, a registry of conservation oriented buyers and sellers of productive Lancaster County farms.

Lancaster Farmland Trust president, Dan Herr, sees the hiring as "a way for the Trust to deal with the increasing number of requests from farmers interested in preservation options. We're pleased to have Karen join our efforts to preserve Lancaster County's treasured farmland."

Ms. Weiss has extensive experience in the farmland preservation field. She has served as the Lancaster County Agricultural Preserve Board's Farmland Preservation Specialist since November, 1986, and she administered the County's easement program during her tenure as the Board's Acting Director in May, 1988-1989. A graduate of West Chester University, Ms. Weiss recently completed the 1989 Management Training Program for Nature Conservation & Historical Preservation Organizations conducted by LaSalle University's Non-Profit Management Development Center, School of Business Administration.
