EPA Approves Chemical Against Potato Beetle

YORK (York Co.) --- Potato growers have been granted special permission by the federal Environmental Protection Agency (EPA) to use a certain insecticide to battle potato beetles.


According to a news release from the York County extension office, the EPA has given the state Department of Agriculture permission to allow the use of sodium fluoaluminate, also known as cryolite, to control Colorado potato beetles on potatoes.

The special exemption lasts until Oct. 31.

Officials also said that future consideration for an emergency exemption use of cryolite will only be done if there is evidence from the state department of agriculture that those using the chemical this year have used it in conjuction with IPMs that incorporate use of the new Bacillus thuringiensis (Bt)

According to the exemption order, "Use of the product Kryocide . . . or Prokil cryolite . . . is authorized. All applicable precautions, directions and restrictions of the EPA-registered label must be followed.

These products will be applied at a maximum rate of 10 to 12 pounds of product per acre per application.

"A maximum of two applications by ground or air equipment is authorized. The number of applications has been reduced to two in order to encourage use of registered alternatives particularly Bacillus thuringiensis in an integrated pest management approach to controlling this pest.

'No application will be made within three days of harvest. A maximum of 22,000 acres of potatoes may be treated.

"Residue levels of flourine resulting from the . . applications are not expected to exceed a 5 ppm in or on potatoes and potatoe processed commodities. This Agency has determined that this level is adequate to protect public health."

According to John Rowehl, York County agricultural extension agent, recommendations for beetle control and suggested IPM strategies incorporating cryolite and Bt have been made by Dr. Zane Smilowitz




