Movement of ready to cook whole fryers was no better than fair but about as expected for mid-week trading. Supplies were generally adequate. Less than ***trucklot***asking prices were steady at 61-76 cents. Live supplies were adequate. Average live weights ranged light to desirable. Processing schedules were heavy. The trade sentiment was steady. In the parts complex, supplies of wings were very tight, whole breasts were in close balance with immediate needs, cutlets were at least adequate, and dark meat items were somewhat irregular and ranged adequate to ample, with reports that some leg items were offered at highly competitive prices to clear.

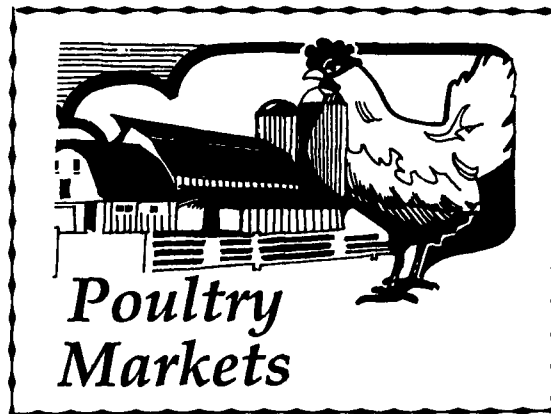
