markets in the past 12 years; not to competition, but to heavily subsidized EC exports.

The cost of the EC's farm subsidy program is staggering, and continues to grow. The EC exports \$32 billion in farm products, less than five percent of the Community's total exports. Yet, in the latest exporting year, the Community spent \$11 billion in direct subsidies to make those sales possible.

"It is estimated that Western European consumers pay an estimated \$54 billion in higher food

prices and \$44 billion in higher taxes due to the common agricultural policies," according to Eckel. "It's total economic nonsense being applied by European leaders to solve a political problem."

Europeans argue current levels of support are needed to keep the 10.2 million farmers on the land, but farmers are leaving the land in great numbers.

Prior to the 1980s, the EC was a net grain importer. Then, as a result of generous internal and external subsidies, EC grain exports grew to 32 million metric tons.

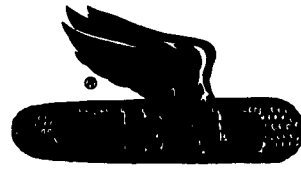
