

# Western Holstein Show In Somerset County

**MEYERSDALE** (Somerset Co.) — The fairgrounds were a virtual sea of campers, horse trailers and trucks during the recent weekend of the Western Pennsylvania Championship Holstein Show. It was the first time Somerset County was selected to host the event.

One hundred and thirty persons registered for the championship show which was an exciting event for show chairman, Mike Stutzman, Friedens, and his committee of planners.

Coming from Titusville with owner Patrick Carey, the grand champion holstein was Plum-Line Melvin Autumn, a senior two-year

old born on Oct. 21, 1988. Sired by Mel-Est Valiant Irose Melvin, Autumn's dam was Campbell-Run Segis Sara from the stock of Patrick Carey.

John Andrew Foster III, Petersburg, was the owner of the reserve grand champion, Globe-Run Starbuck Beverly. Also a senior two year old, Beverly was born on Sept. 16, 1988. Her sire was Hanoverhill Starbuck. Her dam was Globe-Run Bonnies Basket-Twin from stock of John Andrew Foster III.

The junior champion was Park-aces Starbuck Mia, a junior yearling owned by Brian Neely, Emlenton. Mia's sire was Hanoverhill Starbuck. Her dam was C Brucecrest Warden Mia

Marchezak from Bentleyville. Nowerland Trifecta was the sire of Charlene. Coming from owner stock, Charlene's dam was Never-Rest-M Dazzler Charlie.

With ten animals in the show, Bednarski Farms, Avella, Washington County was named premier breeder and premier exhibitor. None of the Bednarski entries were class winners, however, two of them claimed second place in the summer yearling and 6-yr. & over class.

In the individual judging, the Somerset County team of Charles Johnson, Scott and Mark Ream,

placed first with the highest of the combined scores.

Vicki Stahl, Somerset County Dairy Princess and her alternate, Amy Gontis, were joined at the event by two other dairy princesses. Nicki Bozliniski came representing Beaver and Lawrence Counties. Amy Kline represented Butler County.

On the evening prior to the show, time out was taken from all the preparations to enjoy a feast centered around a tasty pig roast so that everybody could relax and get acquainted.
