Plans Under Review

LEESPORT (Berks Co.) - The U.S. Department of Agriculture is reviewing 5 percent of approved Food Security Act (FSA) compliance plans in Berks County to determine the status of practice application.

In Berks County, 1,200 to 1,300 FSA plans have been completed with 60 producers selected for review this fall.

The review will compare scheduled conservation practices and treatments called for in the farmer's FSA plan with progress in applying these practices. The Soil Conservation Service will then determine if the producer is actively applying the plan, not actively applying the plan, or whether the conservation system in the plan has been fully applied.

"In order for a producer to maintain eligibility for future USDA programs, he must apply all his conservation practices by January 1, 1995," said Randy McCormack, district conservationist for the Soil Conservation Service in Berks County.



Soybean **Farmers** Pleased

ST. LOUIS. MO. U.S. soybean farmers are "extremely pleased" with the allocation of \$73 million in GSM 102 funds for soybeans and the increase of \$99 million for protein meal, said American Soybean Association President Gary Riedel.
