Movement of ready-to-cook broiler fryers was slow to fair at best. Supplies were ample and excess product was difficult to place. Less than trucklot asking prices were unchanged to 1 cent lower at 46 to 57 cents. Live supplies were moderate to heavy. Weights were mixed and mostly desirable. Processing schedules were heavy. Trade sentiment was barely steady to weak. In the parts complex demand had slowed on all items and supplies were generally adequate.
