Engineering, Dairy Finance Meeting For Agribusiness

YORK (York Co.) — Whether you are a banker, nutrition/feed representative, builder, veterinarian, or milk equipment dealer, you're often confronted with questions about other dairy management areas — such as dairy finances, cow comfort, and freestalls.

Poor cow comfort is often a secondary cause of many nutrition, health, and production problems on dairy farms.

Financial management is a critical issue on almost any dairy farm.

If you have employees or co-workers who deal with dairy farmers, they should consider attending Penn State Cooperative Extension's agri-business breakfast meeting from 7:30 a.m. to 9:30 a.m., Thursday, July 9 at the Rutters Family Restaurant on Mt. Zion Road, York.

The meeting is as follows: 7:30 a.m. Breakfast of juice, scrambled eggs, sausage, toast and beverage; 8:00 a.m. "Freestalls and Cow

Comfort," presented by Dan McFarland, multicounty agricultural engineer for extension. A discussion of freestalls and how they affect animal comfort and productivity; and 8:45 a.m. "Penn State Financial Analysis Programs for the Dairy Farmer," presented by Roland Freund, area farm management extension agent. An overview of various financial programs available from Penn State extension agents, and how they can help the dairy producer analyze his/her financial and management alternatives.

By having a better understanding of these topics, agribusiness people can provide farmers with answers or refer them to someone who can help.
