Migratory Wildfowl Spread Deadly Strain Of Newcastle

HARRISBURG (Dauphin Co.) — A strain of deadly Newcastle disease has ravaged some wild water-bird populations in the upper Midwest and has been found in dead gulls around Lake Erie, but nationally has not been found in any domestic fowl to date, according to the U.S. Department of Agriculture.

kill, the strain of virus has been responsible for the death of hundreds of young waterfowl in Marsh Lake, located in the southwestern area of Minnesota.

Locally, the problem has not been seen as a threat, but with fall migrations about to start, the possibility exists of the disease being carried along with ducks, geese and shore birds.

Dr. Max Van Buskirk, VMD. director of the Pennsylvania Department of Agriculture's Bureau of Animal Industry, said that he received an informational summary of what has been found from the USDA, but there is no indication that it is a current threat to Pennsylvania poultry producers.

Buskirk said that he is monitoring the situation and depending on federal officials, who have legal responsibility over migratory waterfowl, and USDA officials to keep him informed of any threats.

The state Department of Agriculture is charged with the control and eradication of diseases in livestock and poultry which may affect human health or cause significant economic loss.

Since the disease has not been found in any domestic stock anywhere yet, and the risk to Pennsylvania is uncertain, there is no action required by the state.

Representatives for the state Game Commission were not available for comment by presstime.

However, poultry producers should know that waterfowl and wildfowl which migrate through Pennsylvania often breed in some of the same areas of Canada with the waterfowl which travel the Midwest flyway.

Also, a common flight path for waterfowl is diagonally across the state - from Lake Erie to south-

central Pennsylvania and down the East Coast, according to previous information supplied by waterfowl

Fall migratory patterns of waterfowl are affected by a number of stimuli, including weather. Each species is somewhat different in tolerance of conditions which initiate migration. Therefore, the timing of fall migrations are not exact.

Newcastle disease is caused by a variety of pathogenic strains of viruses. This is a new strain which affects the nervous system of the bird, according to scientists at the APHIS National Veterinary Services Laboratory, in Ames

Although it hasn't been found in domestic poultry, almost any bird, especially species of the parrot family, can carry the infection, according to the USDA report.






