Live supplies were moderate. Weights varied in a full range, but were generally desirable. Less than trucklot asking prices were unchanged to lower at 51 to 60 cents. Trade sentiment was mixed ranging steady to firm. In the parts complex, breast items continued short. Leg items were adequate with leg quarters in heaviest supply. Wings were short.

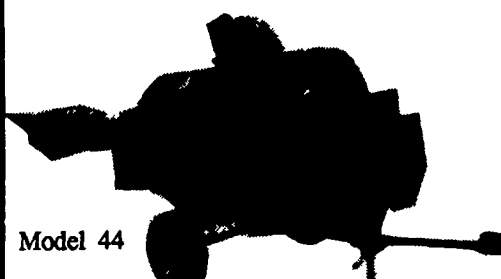

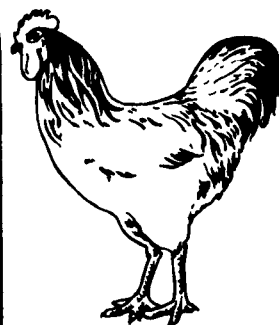
