

### SRBC Announces Meeting

HARRISBURG (Dauphin Co.) - The Susquehanna River Basin Commission will meet at 9 a.m. on Thursday, March 11, at the Robert J. Bielo Building in Harrisburg.

Action items slated for the meeting include ratification of a contract with DER for SRBC involvement in the revision of Pennsylvania's Nutrient Reduction Strategy by which the commonwealth hopes to fulfill its

pledge to reduce nutrient inflows to the Chesapeake Bay by 40 percent.

The commission will also act on staff recommendations for the project applications listed below.

The Commission will hear reports on the hydrologic conditions in the Susquehanna River Basin; the SRBC role in the Pa. Nutrient Reduction Strategy; legislative initiatives on water resource management; a meeting with New York State legislators; the "Lower Susquehanna River Sediment Study;" the Curwensville Reallocation Project; COE Susquehanna River Fish Restoration Study; and hatchery operations at PFBC Van Dyke hatchery & otolithe analysis of American shad.

Project applications being considered include one by the Millersburg Area Authority for ground-water withdrawal of .46 MGD (million gallons per day)

from wells No. 14 and 15 for public water supply, in Upper Paxton Township.

The IBM Corporation seeks approval for ground-water withdrawal of .09 MGD from Wells EN-194 and EN-195 for remediation of ground-water contamination, Village of Endicott, Broome County, N.Y.

Delta Borough Water System is seeking ground-water withdrawal


of .065 MGD from Well No. 8 for public water supply, Delta Borough, York County.

The Huntsville Gold Club has applied for consumptive use of .288 MGD for gold course irrigation in Lehman Township.

Mifflintown Municipal Authority seeks withdrawal of .70 MGD, based on an annual average, from Clearview Reservoir on East Licking Creek, in Milford Township.
