

NATIONAL EGG MARKET - AT A GLANCE: Prices were unchanged to higher in the Northeast and Midwest, unchanged elsewhere. The market tone continued fully steady to firm. Demand covered the full range, was mostly moderate, and was best where retail features were in progress, and where wholesale inquiry for additional eggs was active. Supplies were barely adequate to generally adequate, with jumbos often surplus in the Midwest, and supplies were ample in some West Coast locations. Breaking stock supplies were short to instances adequate, and prices were generally higher. Live hen markets remained at least steady with offerings usually short of the current light to good, and mostly moderate demand.
