USDA Official To Hold Town Meeting

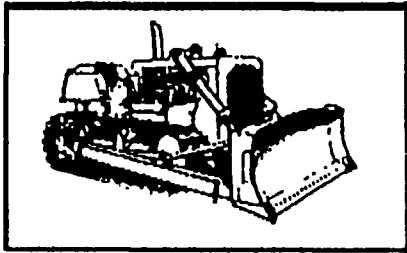
HARRISBURG (Dauphin Co.) — Cheryl L. Cook, Pennsylvania state director of the U.S. Department of Agriculture's Farmers Home Administration, announced that she would be in Berks County on June 23 for an informal "town meeting."

"The idea is to give the people, particularly those who are FmHA Farm or Housing borrowers, a chance to have some say in the future direction of the agency," Cook said. "We are looking for ways to continue our commitment

to public service with a shrinking federal budget, and public input is critical to our success."

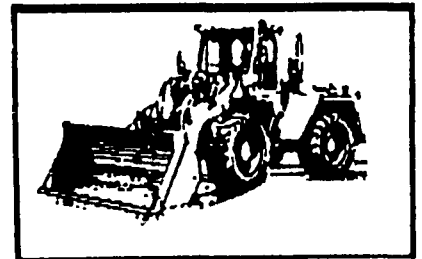
Cook explained that this will be the first of several such opportunities for public input into USDA programs to be held in Pennsylvania this summer.
