NEW ENGLAND: Prices were unchanged on loose large and cartoned eggs while trending lower on loose extra large and jumbo, and trending higher on loose smalls and mediums. Trade sentiment was cautious. Demand was irregular as dealers watched closely for first of the month buying to begin. Supplies were fully adequate on heavier sized eggs while barely adequate to instances short on lighter weight eggs.

Trucklot buying interest was quite irregular and ranged fair to very good. Supplies of boneless skinless breasts with tenders were short of filling current inquiries. Trading was reported on both sides of 1.90 but the undertone was firm for immediate needs and fairly steady going into early next week. Supplies of line run breasts were tight with buyer needs for immediate deliveries not covered. Prices trended higher but some buyer resistance was noted. Dark meat items cleared satisfactorily. Wings were still unsettled. Lin-

ing up trucks to move product to the markets was becoming a problem in some areas. Movement of ready-to-cook whole birds remained about moderate. Offerings ranged adequate to fully adequate. Live supplies were moderate, instances light. Weights were generally desirable. Processing schedules were reduced at some plants but were still heavy in total. Less than trucklot asking prices were unchanged at 52 to 64 cents. Trade sentiment was steady. In the parts complex, breast items, particularly bone-in breasts were in short supply. Legs and leg quarters were in good balance. Wings were not as readily available from several plants, but were still slow to clear at others.
