1987. Three years later, the operation underwent a major expansion with the construction of a 270-head free-stall barn and double-eight herringbone rapid exit milking parlor, and an increase in the Holstein dairy herd from 70 to 300 cows.

Mains is in charge of the dairy operation, crop management, and financial management of the farm.

He assists his father in Pioneer Seed sales and mushroom mulch and tanbark sales.

Mains is also a Soil Conservation Service director, a member of Cumberland County Extension Service board of directors, a member of the York Farm Credit Advisory Council, and a resource and promotion committeeman for Atlantic Breeders.

HUNTINGDON (Huntingdon Co.) — Tax preparers, farmers, agribusiness people, and other interested individuals can secure an update about federal income tax at the 1994 area income tax meeting to be conducted in the following locations:

- January 10 — Mercer County Extension Office, Route 19, north of Mercer.
- January 11 — Butler, Days Inn Motel, Route 8, south, Butler.
- January 12 — DuBois, Holiday Inn, U.S. 219 and I-80.
- January 13 — Mansfield, Comfort Inn, Rt. 15 @ U.S. Rt. 6.
- January 14 — Tunkhannock, Shadowbrook Motel, Rt. 6, 1 mile east of town.
- January 17 — Hazleton, Comfort Inn, I-81 & Rt. 93.
- January 18 — Shamokin Dam/Selinsgrove/Sunbury/Lewisburg, Days Inn Motel, Rts. 11 and 15, Shamokin Dam.
- January 19 — Lancaster/Mt. Joy, Country Table Restaurant, Rt. 230, Mt. Joy.
- January 20 — Chambersburg, Lighthouse Restaurant, Rt. 11 North of Chambersburg.

According to Phil Rzewnicki, county extension director, information presented at this meeting should be helpful as taxpayers

approach the 1994 tax filing season.

The topics covered at the meeting will range from a look at new developments to a review of important tax principles. The program will include a discussion of tax law changes affecting individuals, businesses, farms, and critical issues to be confronted by taxpayers when they file the 1993 tax return. Handout materials will be provided to support discussion by the instructors.

Penn State Faculty representing farm management extension will serve as instructors for each of the sessions.

Starting time for the income tax meeting is 8 a.m. The session will end at 4 p.m. The registration fee is \$40 per person including lunch and reference materials. The registration deadline is December 10. A late registration fee of \$10 will apply to registrations post-marked after December 10.
