DAILY NATIONAL GRAIN SUMMARY WEDNESDAY'S WHEAT PRICES JUMPED SLIGHTLY HIGHER ON VERY GOOD EXPORT DEMAND AND IDEAS USDA WILL LOWER ENDING STOCKS FIGURE THIS WEEK. CORN AND SOYBEAN PRICES RECEIVED MODERATE SUPPORT FROM IMPROVED EXPORT INTERESTS, INCREASED DOMESTIC DEMAND FOR CORN, AND COMMERCIAL BUYING ON THE BOARD. WHEAT 1 TO 3 CENTS HIGHER EXCEPT ST LOUIS DOWN 2 CENTS. CORN 1 TO 2 CENTS HIGHER. SORGHUM 3 TO 5 CENTS HIGHER. SOYBEANS 1 TO 3 CENTS HIGHER. WHEAT PRICES CONTINUED TO CLIMB ON VERY GOOD EXPORT SALES THIS WEEK WITH THE PHILIPPINES AND FORMER USSR BIG BUYERS. USDA'S SUPPLY/DEMAND REPORT IS DUE THURSDAY AND TRADERS EXPECT THE 93/94 CROP YEAR ENDING STOCKS FIGURE TO BE LOWERED IN REACTION TO INCREASED EXPORT DEMAND UP UNTIL NOW FOR WHEAT. KANSAS CITY WHEAT IS AROUND 50 CENTS HIGHER THAN A YEAR AGO BUT MINNEAPOLIS SPRING WHEAT IS SUBSTANTIALLY HIGHER DUE TO POOR MILLING QUALITY WHEAT BEING SOLD. SLIGHTLY HIGHER CORN PRICES WERE INFLUENCED BY IMPROVED EXPORT OUTLOOK FOR U.S. CORN WITH REPORTS BRAZIL WILL SOON TENDER FOR 300,000 TONNES. GOOD DOMESTIC DEMAND FOR CORN HAS BEEN NOTED AS THE NUMBER OF CATTLE ON FEED AND INCREASED POULTRY NUMBERS ARE UP IN RECENT WEEKS. SOME FARMER SELLING HAS LIMITED PRICE GAINS. SOYBEAN PRICES UP SLIGHTLY DUE TO COMMERCIAL BUYING ON THE BOARD AND GOOD FOREIGN DEMAND. LIGHT FARMER SELLING OF BEANS ALSO UNDERMINED BEAN PRICES.
EXPORT NEWS: THE USDA ACCEPTED EIGHT BIDS TO SELL 185,295 TONNES OF NORTHERN/DARK NORTHERN SPRING WHEAT

AND 81,705 TONNES WESTERN WHITE WHEAT TO THE PHILIPPINES UNDER BFP FOR JAN/MAR SHIPMENT. THE PHILIPPINES BOUGHT 75,245 TONNES HARD RED SPRING WHEAT AND 29,755 WHITE WHEAT FOR 93/94 MARKETING YEAR. UZBEKISTAN BOUGHT 100,000 METRIC TONS HARD RED WINTER WHAT FOR 93/94 MARKETING YEAR. THE SALE OF 100,000 METRIC TONS OF HARD RED WINTER WHEAT TO UNKNOWN DESTINATION FOR 93/94 MARKETING YEAR WERE REPORTED. PURCHASES FROM FOREIGN SELLERS FOR 100,000 METRIC TONS HARD RED WINTER WHEAT TO UNKNOWN DESTINATION FOR 93/94. THE USDA ACCEPTED THREE BIDS TO SELL 11,700 TONNES HARD RED WINTER WHEAT AND 4,680 TONNES NORTHERN/DARK NORTHERN SPRING WHEAT TO MEXICO UNDER BFP FOR DEC/JAN SHIPMENT. THE USDA ACCEPTED ONE BID TO SELL 50,000 TONNES HARD RED WINTER WHEAT TO EGYPT UNDER BFP FOR DECEMBER. THE USDA ACCEPTED ONE BID TO SELL 100,000 TONNES HARD RED WINTER WHEAT TO THE FORMER SOVIET UNION UNDER BFP FOR JAN/MAY SHIPMENT. THE USDA HAS ACCEPTED ONE BID TO SELL 1,000 TONNES OF SUNOIL TO MEXICO UNDER THE SUNFLOWERSEED OIL ASSISTANCE PROGRAM FOR FEB/APR SHIPMENT. RUSSIA BOUGHT APPROXIMATELY 120,000 TONNES SOYMEAL FOR DECEMBER SHIPMENT.

Asking prices trended higher and the undertone was firm for immediate delivery but unsettled for next week. Dark meat items were well cleared. Wings were tight and prices were firm.
