Monroe County Recognize 4-H'ers

Members and leaders of the Monroe County 4-H Club, the R & R Rabbit Club, attended the Monroe County Commissioners meeting recently at the Courthouse in Stroudsburg.

The youth members and adult leaders of the 4-H club were recognized for the hard work they have put forth in presenting the R & R Rabbit Club show, parade,

and auction, held annually in September. This year marked the 5th year the 4-H club has sponsored this community event.

al leader, and to the club coleaders Ryan Argot, Winnie Dorpfeld, the Carol Taran.

Members of the R & R Rabbit Club (Sara Smith, club president; Mary Jane Kizakavich, club secretary; and Drew Norman, club treasurer) presented certificates to the three County Commissioners for their support of 4-H. Two of the three Commissioners, Janet Weidensaul and James Cadue, marched in the R & R Parade in September, in response to an invitation sent to them by the 4-H Club youth members.

After observing the commissioners' meeting, which was conducted with the same parliamentary procedure which they have learned and utilize in their 4-H

witnessed emergency information being received and emergency assistance being dispatched.

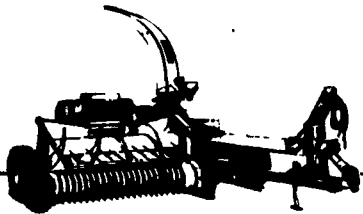

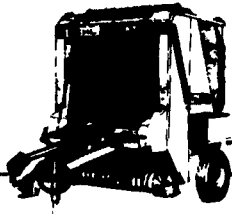

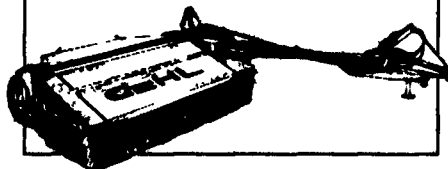
