

Finalizes ROR EPA

ST. LOUIS, Mo. - National Corn Growers Association (NCGA) president and Essex, Iowa farmer Pete Wenstrand commended the Environmental Protection Agency (EPA) for a "job well done" in finalizing the regulations for the Renewable Oxygenate Requirement (ROR).

The ROR exemplifies the dedication of the Clinton Administration to expand the use of renewable forms of energy, like ethanol," said Wenstrand.

The announcement by the EPA culminates a year long, highly contested struggle by the EPA to require that 30 percent of the oxygen required in the reformulated gasoline program (RFG) be

derived from renewable sources. In a presentation to the Governors Ethanol Coalition in Milwaukee, EPA Air and Radiation Administrator Mary Nichols said, "The ROR is just the beginning of a long process to expand the use of renewable fuels. This administration is fully committed to the ROR program and this is just the first step in reaching our long term objectives."

"NCGA," said Wenstrand, "is tremendously excited about the future prospects this program holds for agriculture. The ROR will create additional demand for corn by as much as 100-200 million bushels in 1995-96 and even more in the out years of the prog-

ram. This is a longterm commitment by the Clinton administration and will have a profound impact on the future of the ethanol industry. Our focus has always been to ensure the viability of the ROR and therefore we have endorsed a one year phase-in of the 30 percent rule, in order to maximize its opportunities for success."
