

RISA Seeks Proposals For On-Farm Projects

LEESPORT (Berks Co.) — The Regional Infrastructure for Sustaining Agriculture (RISA), a three and one half year program focused on long-term farm issues in southeastern Pennsylvania, is seeking proposals from southeast Pennsylvania dairy and vegetable farmers for on-farm research or demonstrations that address an aspect of sustainable agriculture.

Specifically, RISA is interested in proposals for sustainable technologies or practices farmers want to evaluate on their farm, as well as innovative strategies for sustaining the long-term viability of farming operations. In southeastern Pennsylvania, RISA will provide some technical and financial support to the project.

Priority will be given to proposals that address the following issues: nutrient management, marketing, intensive grazing, water quality, soil health, integrated pest control, total farm management and alternative crops. Other ideas that contribute to the long-term sustainability of farming will also be considered.

RISA is a cooperative project being conducted by Penn State

University, Rodale Institute Research Center, Pennsylvania Association for Sustainable Agriculture (PASA), Atlantic Dairy Cooperative, Reading Terminal Farmers Market Trust, and the League of Women Voters. The project is based in southeastern Pennsylvania, including Northampton, Lehigh, Bucks, Berks, Montgomery, Philadelphia, Delaware, Lebanon, Lancaster, and Chester counties. It seeks to address the food system infrastructure in the rapidly urbanizing counties, and better ways of integrating farmers and consumers, production and markets.

RISA activities are under way to identify and broaden the understanding of barriers to and opportunities for sustaining agriculture in the region. The southeast on-farm demonstrations will provide farmers the opportunity to test and demonstrate innovative agricultural practices which work for them and a way to share the results with others.

Are N.Y. Farmers At Disadvantage?

ALBANY, N.Y. — At a recent news conference sponsored by the New York State Association of Counties, New York Farm Bureau President Charles Wille said that unbearably high property taxes are squeezing the profitability out of farming and putting New York farmers at a competitive disadvantage with their counterparts in other states.

During the news conference, the Center for Government Research (CGR) unveiled a study on the high cost of state mandates and their impact on county taxpayers. The study focused on a direct county-to-county comparison

between Monroe County, in western N.Y., and several similarly-sized municipalities around the country.
