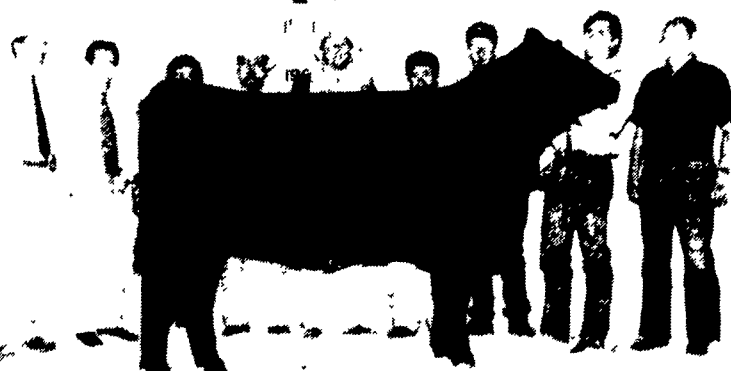
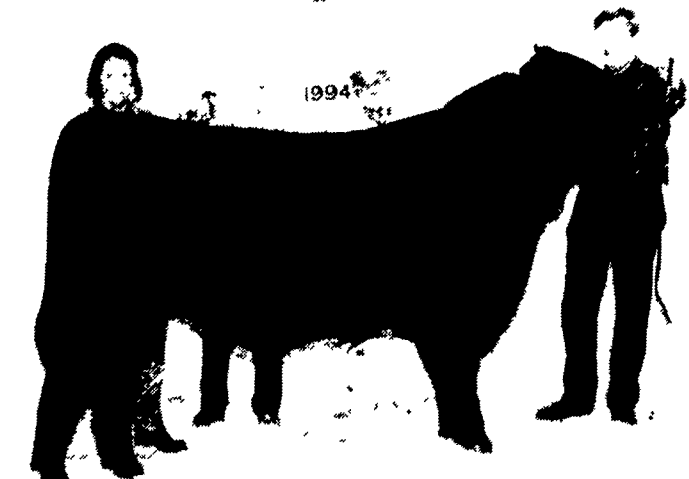


# Angus Breeders Exhibit 76 Cattle At State Fair Of Va.

The bull first won the junior division and is an April 1993 son of V D A R New Trend 802.

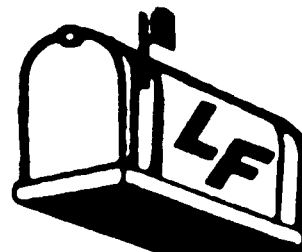
