Commends Garrahan

According to a news release, Wolff commended Garrahan for being named the Pesticide Inspector of the Year by the EPA Region III office. Garrahan was presented with the EPA award during a recent state pesticide inspector workshop.

The award is presented by the EPA to the person who best exemplifies an "outstanding inspector," based on exceptional dedication, performance of duties in a consistently professional manner, completion of inspections with proper documentation, seeking innovative approaches to problems and functioning as an educator to the regulated community and the public, according to the news release.
