

**Editor:** 

This letter is being written in response to your editorial of May 13, 1995, in which you expressed support for private landowner compensation in matters involving the enforcement of environmental/ natural resource related regulations.

As patriotic Americans who serve as stewards of our country's land and water resources; as a people that appreciate and respect God's creation, why must we be paid not to destroy or damage fragile environmental resources such as springs, seeps, streams, wetlands, and endangered species' habitat such as bald eagle nesting sites?

Paradoxically, it is more frequently the case that private property values are increased by taxpayer or government investments in such improvements as roads, utilities, parks, and by favorable zoning. Should not the property owner reimburse the government in these cases in order to be consistent with your philosophy? Also, should not a private landowner reimburse his or her neighbors when the use or abuse of their property results in a decline in value to his neighbor's property? And should not the landowner, when his exceptional stewardship of his property results in increasing the value of surrounding properties, be compensated?

Private property rights need to be protected. Just compensation when land is purchased by the government is critical. (Also purchase of eminent domain needs to fully be justified before being applied.) Landowners, however, need not be paid to be good stewards. That is our responsibility and accompanies the right to own land.
