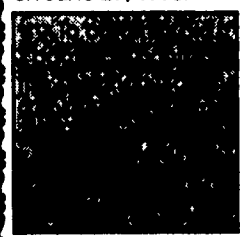
The Lebanon County Conservation District is requesting BIDS for the construction of a roofed barnyard, to be funded in part by the Chesapeake Bay Program.
