Prices were generally unchanged. The market tone was mostly steady to instances fully steady. Inquiry for immediate delivery was fair, interest for future commitments was light to fair, and most plants remained busy packing previous commitments. Floor stocks of frozen products were adequate. Raw material offerings were generally adequate, and prices were mostly unchanged following previous week increases. Liquid and frozen eggs processed under federal inspection in the Eastern region for the week ending June 24, 1995 were 5% less than last week, and 3% more than the same week last year.

Movement of ready-to-cook whole birds was good. Seller offerings were in good balance to closely cleared, particularly on the smaller sizes. Live supplies were moderate; weights were mixed in a full range of light to heavy. Processings schedules were very heavy. Less than trucklot asking prices were 1 cent higher at 55 to 66 cents. Trade sentiment was fully steady to firm. In the parts complex, supplies of wings were fully adequate. Other items were generally well balanced to instances short, especially boneless skinless breasts.

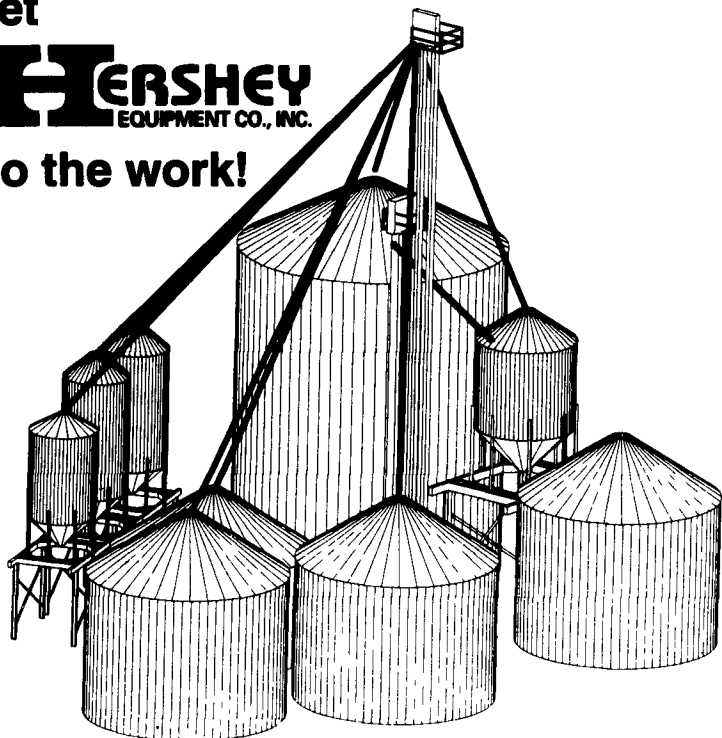
