Wheat and corn bids were higher,

supported by continued export optimism and crop concerns. Soybean bids slipped lower, correcting some of Tuesday's advances. Wheat 1 to 2 cents higher. Corn 2 to 9 cents higher. Sorghum 2 to 3 cents higher. Soybeans 1 to 3 cents lower, except Southern Iowa 2 to 6 cents higher. Export demand remains slow for wheat the past couple of days. However, traders remain optimistic with indications that Brazil and Morocco are seeking US wheat. Spillover strength from corn pits offered support to wheat. Corn bids were stronger on good export sales as South Korea has been a big buyer of corn this week and traders are staying optimistic. Corn harvest has begun in northern states but some signs of damage after last week's freeze is showing up in several places, especially for soybeans. Soybean bids fell slightly lower as a corrective move over yesterday's upturn. Upcoming harvest pressure may have put some pressure on bids. Export demand has slowed down and the decline in meal demand was also a factor. Nebraska reported that freeze damage to bean crops is showing up more widespread than expected which will trim yields and limit declines.
