

is less than 5 percent of the minimum requirement for the bitch, the housing shall be approved by the. attending veterinarian."

This last part is an example of some of clarification of what is the expected responsibility and competency of attending veterinarians.

The watering requirements for dogs being transported have been made more specific and demand more attention by the caretaker.

Under the old set of rules, water was only required once every 12 hours, while dogs were being transported.

Under the new regulations,

mature dogs (those over 6 months old) must be offered fresh water for at least a 10-minute interval every six hours.

For dogs under 6 months, the requirement is to be fresh water being offered for at least 10 minutes every four hours.

The department may also now test or require testing of water offered to dogs, and may make inspections of facilities at any time.




