Adams Holstein Club Sets Calendar

GETTYSBURG (Adams Co.)—Closing in on a goal, the board of directors of the Adams County Holstein Club met Wednesday afternoon, Jan. 24, at the Penn State Extension Office to review progress with the membership drive and formalize a calendar of meetings and events for the coming year.

Kevin Holtzinger presided, while state director Marvin Brown, who is directing the membership drive, spoke about those efforts.

County Agent Thomas E. Piper reported that Galen Kopp, dairy agent and Kirby Horst, president of the Holstein Club in Lebanon County are developing an itinerary for hosting the Adams County Holstein Club to a tour being planned for April 9. Details will be announced later.

Charged with responsibility for organizing the dairy princess coronation, Josie Riser and Alan Zepp are to recruit prospective candidates and plan an appropriate event in early summer.

The board agreed to visit Mason-Dixon Farms Dairy for the annual summer twilight meeting. Josie Riser and John Clowney are to make arrangements.

A possible type classification meeting is contingent upon timing of official herd classification work and could be delayed until February 1997 at the Penn State Gate farm near Littlestown.

Chris Wood reported plans to take several junior members to the youth convention in Williamsport.

She said she will seek to inspire interest in judging with participation in the Hoard's Dairyman Contest and by pushing for participation in the July 10-11 judging school in Lancaster County.

As fundraisers, John Clowney agreed to chair the ice cream sale at the Kingsdale Carnival in August. Chris Wood is to direct the cheese sale in the fall of 1996.

The board is to conclude the membership campaign at a spouse's night dinner meeting on Feb. 17. A director's picnic and meeting is to be held Sept. 15, and plans were initiated to hold the 45th annual banquet meeting on Thursday, Oct. 24.

Just before the meeting adjourned, Piper encouraged the directors to invite their dairy farmer neighbors to a Crops Day Program on Feb. 5, at the Adams County Extension Office where a portion of the program will be devoted to Nutrient Management plans and the efficient handling of hay in large round bales.

The Four Seasons of Grazing Teleconference is to be downlinked to the county office on Feb. 8; the Dairy Nutrition Workshop featuring current concepts in dairy nutrition will be offered on Feb. 22 and 29.

Also announced, a DHIA records workshop is to feature Dean Amick and David Sherk from the Pa. DHIA staff, and Dr. Larry Specht, an extension dairy specialist, from 10 a.m.-2:30 p.m., on Monday, Feb. 26, at the Adams County Extension Office.

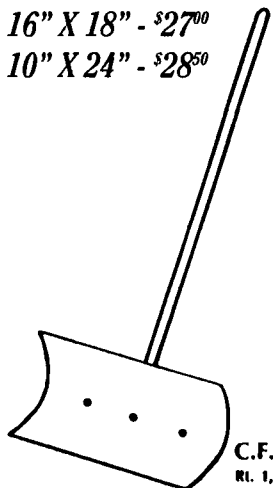
