The market tone was barely steady to weak for large and extra-large, and steady for mediums, smalls and jumbos. Demand was light to instances fairly good, mostly fair, and best where featured. Supplies were adequate to ample for the large and extra-large, and light weight eggs and jumbos remained no more than adequate. Breaking stock supplies were adequate from regular sources and surplus offerings, and the market tone held steady. Live hen offerings were fully adequate to ample for the limited demand.

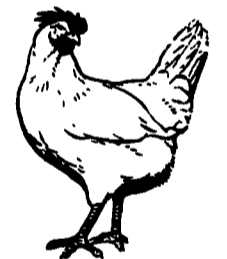

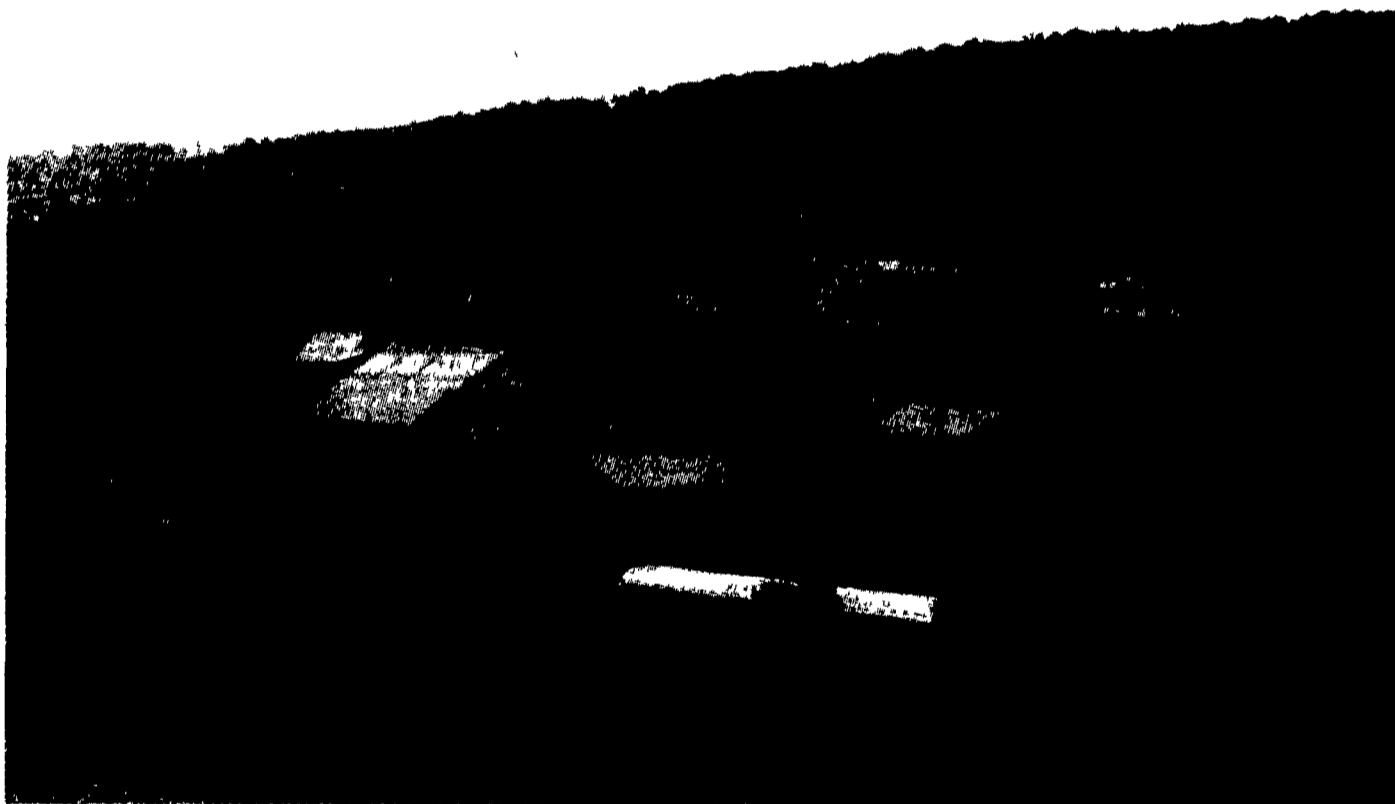
