

ALBANY, N.Y. — Dairy farmers who supplied milk dealers (handlers) under the New York - New Jersey marketing orders during March 1996 will be paid by handlers on the basis of a uniform price of \$13.48 per hundredweight (29 cents per quart); the price for the corresponding month last year was \$12.51 per hundredweight, according to Market Administrator Ronald C. Pearce also state that the price was \$13.59 in February 1996.

A total of 11,195 dairy farmers supplied handlers regulated under the New York - New Jersey marketing orders with 1,051,225,569 pounds of milk during March

1996. This was an increase of 1.6 percent (about 17 million pounds) from last year.

The gross value to dairy farmers for milk deliveries was \$143,154,992.43. This included differentials required to be paid to dairy farmers but not premiums, deductions authorized by the farmer, or assessments.

Regulated handlers used 419,926,529 pounds of milk for Class I, 39.9 percent of the total. This milk is used for fluid milk products such as homogenized, flavored, low test, and skim milks. For March 1996, handlers paid \$15.15 per hundredweight (32.6 cents per quart) for Class I milk compared with \$13.77 a year ago.

Handlers used 178,362,652 pounds of milk for Class II products, 17 percent of the total. Class II products include fluid cream, eggnog, ricotta and cottage cheeses, ice cream, and yogurt. Handlers paid \$13.03 per hundredweight for this milk.

Milk used to manufacture Class III products including butter, cheese (other than ricotta and cottage cheeses), and whole milk powder totaled 418,650,759 pounds (39.8 percent of the total).

Handlers paid \$12.65 per hundredweight for this milk.

Milk used to manufacture non-fat dry milk (Class III-A) totaled 34,285,629 pounds (3.3 percent of the total). Handlers paid \$10.27

per hundredweight for this milk. The uniform price is based on milk containing 3.5 percent buterfat. For March 1996, there was a price differential of 5.4 cents for each one-tenth of one percent that the milk tested above or below the 3.5 percent standard.

the insect community will return."

While Arnold points out that diversion wells are not a long-term solution to acid mine drainage, results of Penn State tests show that citizens' groups and other agencies can maintain a diversion well inexpensively and improve acidic streams to levels that allow stocking and fishing. He adds that coal companies can use the wells as part of their clean-up efforts on active and abandoned mines. A di-

version well can be built for about \$5,000. A year-long supply of limestone can cost approximately \$2,000. "Conceivably, hunting and fishing associations or other groups could maintain a diversion well to establish a stocked fishery," Gray said.

"These wells are very effective and very easy to maintain, which is important when installing one deep in the woods of Pennsylvania," Arnold said.
