Yolks traded in a wider price range, and most sales were unchanged to lower. The market tone was about steady for yolks, and no better than steady on the balance with whites in the weakest position. Demand was light, and most plants focused on filling previously negotiated commitments. Floor stocks were adequate. Edible liquid and frozen eggs (ingredients included) processed under federal inspection for the week ending June 22, 1996 in the Eastern region were 15% less than last week, and 13% less than last year.

Movement of ready-to-cook whole birds was good to very good. Offerings were closely cleared to fully adequate and sizes varied from plant to plant. Live supplies were moderate; weights were mixed in a full range of light to heavy. Processing schedules were moderate. Most plants plan to close tomorrow in observance of the holiday. Less than trucklot asking prices were generally unchanged at 60 to 74 cents. Trade sentiment was steady to firm. In the parts complex, bone-in breasts and leg quarters were no more than adequate. Other parts continued to clear well, however most items were adequate for immediate needs.

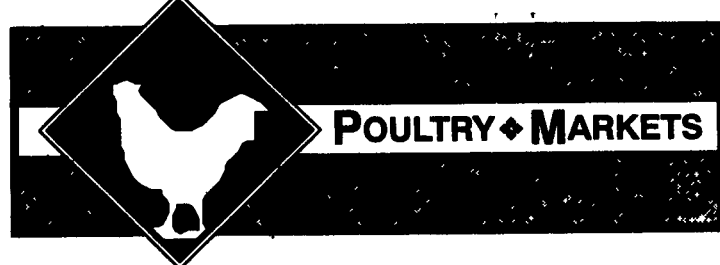

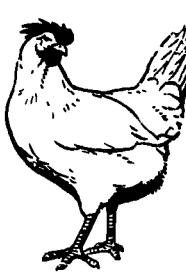
