Live supplies were moderate; weights were mixed in a full range of light to heavy. Processing schedules were moderate. Most plants plan to close tomorrow in observance of the holiday. Less than trucklot asking prices were generally unchanged at 60 to 74 cents. Trade sentiment was steady to firm. In the parts complex, bone-in breasts and leg quarters were no more than adequate. Other parts continued to clear well, however most items were adequate for immediate needs.




