According to the Lancaster Chamber of Commerce, if a comparative sales analysis indicates that your property has grounds upon which to appeal, then this database is capable of providing you with documentation that will be helpful in the appeal process.

One of the most effective methods for establishing the value of an individual's property is through comparable sales, which

# Sugar, Vegetables On Tap For Tours

FREMONT, Ohio - What could be better than a complimentary meal, a relaxing wagon tour, and lots of useful information on how to improve your livelihood?

That's exactly what sugar beet and vegetable growers will get when they attend two tours August 7 in Fremont at the Ohio Agricultural Research and Development Center's Vegetable Crops Branch.

From processing tomatoes to pumpkins and potatoes, the latest research results will be on display at the Vegetable Crops Field Day from 3 p.m.-6 p.m. Both OARDC and Ohio State University Extension scientists will be on hand to answer questions about growing vegetable crops.

The program will include information on processing tomatoes, cultivar trials, pumpkins and potatoes. In addition, visitors can rest their feet by taking wagon tours of the various research plots.

OARDC Director Tom Payne will give opening remarks. Admission is free and open to the public.

The Sugar Beet Twilight tour will last from 5:30 p.m.-7:30 p.m., immediately following the Vegetable Crops Field Day.

"The purpose is twofold," said Ken Scaife, manager of the Fremont farm. "One is to ... bring the sugar beet growers together for a meeting to look at some of the research projects we have going on here. And secondly, to stimulate greater interest in sugar beef production here in the northwest Ohio and the southeast Michigan growing region.

'The reason that we're running the two concurrently is so that any interested vegetable growers that will be coming to the 3 p.m. tour will have the opportunity to hear some of the opening comments by the Great Lakes Sugar Co.," said

"Perhaps they can recruit some growers that used to grow for them or get some new ones."

In between the two events will be a complimentary meal sponsored by Great Lakes Sugar Co., George F. Ackerman Co., and Rohm & Haas Co. with refreshments provided by Grower Service Corp.

"We'll be looking at some sugar beet research that is being conducted," said Scaife. "Those are topics in weed management, cultivar evaluation, and stand establishment. These are all areas of research that are being conducted kind of in a coopertive effort among us here at the Vegetable Crops Branch, the Great Lakes Sugar Co. and their Growers Association."

The sugar event is sponsored by OARDC and Ohio State University Extension in cooperation with Great Lakes Sugar Company; Fremont, Findlay and Blissfield Sugar Beet Growers Association; and Sandusky Soil and Water Conservation District. can be obtained through an appraisal or through the database offered by Keystone Farm Credit.

The Keystone Farm Credit database is a well-documented program administered by a certified staff and is comprised of 131 private and public sales from Lancaster County. It is continuously updated to provide current and accurate information and is utilized by the Farm Service Agency because of its policy of incorporating only sales within the last two

years. This database was created to service Keystone loan officers and appraisers contains a range of typical market values of farms based on five zones in Lancaster County. The values are broken down into land, building, type of soil, and other variables.

This comparative analysis database contains nonresidential comparative sales for every county in Keystone's service area except for Delaware and Philadelphia counties. Due to the high volume of sales and to insure accuracy of this database, Keystone's two branches in Lancaster County are monitored bi-annually.


The reassessment appeal will take place in the Reassessment Department of the Lancaster County Courthouse and will consist of a 10-minute session. During this time the property owner will be able to present evidence to one member of the assessment board that indicates that the reassessment of their property is inaccurate. Information that a property owner may want to consider bringing to their appeal includes anything that the property owner considers as evidence of the value of the property. As LaGore suggested, one must be prepared with documentation to most effectively present their case at the appeal.

The Keystone Farm Credit database provides information that is available to farmers for a small fee and will be a great resource for those preparing for an appeal. The database offers a method to determine if an appeal is feasible and a method by which to adequately prepare for the appeal process.

If you are interested in seeking the services of Keystone Farm Credit to aid you in preparation for an appeal, you may contact your local branch at Quarryville (786-7007) or Lancaster (291-1858).

To develop comparative sales analysis with Keystone, the property owner must be prepared with information that indicates the location of the property, basic building sizes, and assessed values. The services of the Keystone Farm Credit are available to any owner of nonresidential property and anyone choosing to utilize the services offered by Keystone Farm Credit should expect to pay a nominal fee.

LaGore also offered a word of caution: "The comparative analysis database may confirm or question the assessed value of a property." The best thing to do is to be prepared.
