




## Maryland FFA Land Judging Contest

contest is sponsored by the Maryland Association of Soil Conservation Districts as a special project of the Maryland FFA Foundation, Inc. The high scoring individual for the Land Judging Contest was Sherry Riggleman, member of the Clear Spring FFA Chapter. The Clear Spring High School FFA Chapter took the second place banner in the contest.

The members were then to recommend the best management practices for agricultural and non-agricultural land uses at each site. Jim Brewer and Phil King of the Soil Conservation Service supervised the contest.

The winning teams in the land judging contest from first through third were Frederick High School, Clear Spring High School, and Queen Ann's High School.
