U.S. Senate Ag Committee Introduces Proposals

WASHINGTON, D.C. — U.S. Senate Agriculture, Nutrition and Forestry Committee Chairman Dick Lugar has introduced legislation to renew the lapsed presidential fast-track authority needed to negotiate trade agreements and knock down trade barriers.

Lugar also joined 55 members of the Senate to introduce legislation that overturns an IRS ruling that would make farmers pay taxes on income they have not yet earned.

Fast-track is the procedure Congress uses to consider and approve trade agreements, negotiated by the President. Under the system, Congress has 60 days to approve an agreement following presidential submission.

Lacking fast-track authority, many countries are reluctant to negotiate with the United States fearing that concessions they have already made could be amended by Congress, forcing further negotiations and more concessions.

"In 1996, agricultural exports reached a record of \$59.8 billion. Continued growth is vital," said Lugar, a senior member of the Senate Foreign Relations Committee. "World Commodity markets are often distorted by import barriers, export subsidies and state trading enterprises. These distortions put American farmers and agribusiness operators at a disadvantage. We must reduce trade barriers and allow our industry to supply the world's markets.

tinue to move forward in its effort to find new markets for our goods and services. We should take advantage of a favorable trade climate in South American by pursuing an agreement with Chile, which has advanced bilateral trade agreements with Canada and Mexico and has become an associate member of the Southern Cone Mercosur trading bloc.

"Before the United States can move forward, the Administration must have fast-track authority. The President must now make a case to Congress and the American people that this is a priority of his administration," Lugar said.
The bill, titled the Trade Agree-

ment Implementation Reform Act (TAIR), allows legislation submitted under fast-track authority to contain only provisions absolutely necessary to implement an agree-

Prior law allowed provisions "necessary and appropriate" and encouraged deals with special interests in exchange for support.

Fast-track legislation could not be amended except to delete provisions that merely offset revenue losses from tariff changes. Lugar also introduced that fast-track bill in the last Congress.

The Internal Revenue Service said last year they would expect farmers to pay tax on income in the year that a commodity contract is made, not the year in which the cash is received. This would even apply to farmers who use cash basis accounting.

"The IRS position is wrong and regrettable. It will result in farmers being hit with huge unexpected tax bills," said Lugar, an original co-sponsor of the bill.

"The use of deferred contracts has been an important tax management tool for cash basis farmers since Congress eliminated income averaging in 1986. Farmers have little or no control over the price of crops or livestock and the weather conditions under which they produce commodities. The use of deferred contracts assists them in averaging their annual income flow and the resulting tax liability," Lugar said.

"The IRS position ignores the fact that our family farmers are, by statute, expressly permitted to manage their businesses on a cash

basis and that amounts received under deferred payment contracts may be handled this way," Lugar (R-Ind.) said.

The bill, known as the Family Farm Alternative Minimum Tax Relief Act of 1997, has broad bipartisan support including both the Senate majority and minority
