## Brazil American Jersey Sale Breaks World Record

REYNOLDSBURG, Ohio The first Brazil-American Jersey Sale was held in Sao Paulo, Brazil on April 26, 1997.

The sale averaged \$8,811.55 on 38 lots. This is the highest average in history for a Jersey consignment sale.

The 38 lots of cows and heifers were consigned by 26 U.S. Jersey breeders from nine states. The sale was a joint project between the Brazil Jersey Cattle Association, Pinheiro Machedo Ltd, Brazil; American Marketing Service, Va.; and the American Jersey Cattle Association.

Topping the sale at \$30,491 was BW Duncan Chief 1265, EX-90%, consigned by Brentwood Farms, Orland, Calif. "1265" has a projected mature equivalent (ME) of 27,962 pounds milk, 1,252 pounds fat and 957 pounds protein.

SSF Legendary Felicia, consigned by Charles Luchsinger,

Syracuse, N.Y., was the secondhighest selling animal. The final bid was \$24,845 for the 2-year-old daughter of Schultz Performing Legend. Felicia's" dam has a twolactation mature equivalent (ME) average of 17,162 pounds milk, 843 pounds fat and 706 pounds protein.

A daughter of Rocky Hill Sky Line, Skyline Lauren, EX-93%,

consigned by McKee Jerseys, Faunsdale, Ala., was the third high-selling animal. "Lauren" brought \$23,151. "Lauren" has a projected ME of 23,386 lbs. milk, 981 lbs. fat, and 856 lbs. protein.

All handouts and materials regarding the acts, which are available from the tax assessment office are to be available at the meetings. The meetings are all scheduled to start at 7:30 p.m.




