DAILY NATIONAL GRAIN SUMMARY

Export disappointments and board corrections pressured wheat bids lower, today. Corn bids were moderately higher in reaction to the decline in the U.S. crop rating. Strong demand for soybean meal pushed bean bids higher. Wheat steady to 4 cents lower. Corn steady to 8 cents higher. Sorghum mixed. Soybeans 1 to 13 cents higher. Egypt's recent tender for 50,000 tonnes of U.S. wheat was canceled, adding weakness to wheat bids. Slowed export demand and reported rainfall in Australia's wheat growing areas were also pressure factors. Higher corn bids were due in part by declines made in the crop rating, with good to excellent estimate down to 62 percent. Last week's estimate was 63 percent. Reports that Korea bought corn from China after passing on a tender for U.S. corn, limited gains. Soybean bids climbed upward as demand for soybean meal improved.
