

Gettysburg Rancher Elected Director

GETTYSBURG (Adams Co.) — Tom Brown of Gettysburg was elected director of the Texas Longhorn Breeders Association of America (TLBAA) at its 33rd annual general membership meeting in Fort Worth, Texas.

The oldest and largest Texas Longhorn registry in the world, the TLBAA was organized in 1964. It has more than 4,200 members across the United States, Canada, and five foreign countries and maintains records on almost 250,000 animals at its office in Fort Worth, Texas.

Brown and his wife, Susie, operate Triple Ring Ranch, where they have raised Texas Longhorn cattle since 1991. The historic value of the breed appeals to the Browns, as well as the Texas Longhorn's ease of maintenance and production of naturally lean beef.

Entomologists Get First Look At New Insecticide Compound

NASHVILLE, Tenn. — The first research data from tests with a novel, new insecticide compound were introduced by scientists from Novartis Crop Protection, Inc., at the Entomological Society of American Annual Meeting.

Six papers were presented indicating that the new compound shows promise for control of sucking and chewing insects in more than 20 crops, with low-use rates and minimal impact on beneficial insects.

Novartis has designated the compound as CGA 293'343, a novel, neonicotinoid class insecticide with a unique structure. Novartis indicated that a common name has not yet been approved by ISO-9000. The research presented today shows CGA 293'343 is active against aphids, Colorado potato beetle, leafhoppers, leafminers, scales, thrips and whiteflies. The compound has a unique mode of action interferring with specific nicotinic acetyl choline receptors through contact and ingestion.

The Novartis researchers reported results with CGA 293'343 in such crops as apples, citrus, cole crops, cotton, grapes, potatoes, tobacco and vegetables, at rates ranging from 0.2 to 2.0 ounces of active ingredient per acre. For example, in a recent field trial conducted in Arlington, Wis., treatments of CGA 293'343 were applied in-furrow to control the Colorado potato beetle. CGA 293'343, applied at 1.0 and 1.5 grams of active ingredient per 100

meters (6.0 to 9.0 ounces of a 2SC formulation), provided almost 100 percent control of the target pest.

Data were also presented showing that CGA 293'343 is effective in a variety of applications, including seed treatment, in-furrow and as a foliar spray.

"Growers around the world tell us they need effective, targeted insect control products that fit integrated pest management strategies," said Dr. Hans Elmsheuser, director, product management, insecticides, Novartis Crop Protection in Basle, Switzerland. "To meet that need, Novartis Crop Protection is committed to developing compounds like CGA 293'343 through the best combination of biological technology and traditional chemical research."

DES MOINES, Iowa — D.L. (Dick) Reasons was named president and chief executive officer of Optimum Quality Grains, the joint venture between DuPont and Pioneer Hi-Bred International that was formed to speed the discovery, development, and delivery of new crops that benefit farmers, livestock producers, and consumers worldwide.
