Trucklot buying interest varied according to end users needs. Offerings were confidently held with the best movement noted in other than regular channels. Promotional interest centered on attractively priced red meat items. Movement was best into fast food outlets as widespread media ads stimulated consumer buying interest. Retail demand was very light with several distributors showing hardly any interest in high priced poultry items. The market tone was fully steady to firm as influence from other aspects of the market continued to clear most available product.

Movement of ready-to-cook whole birds remained seasonally good and was sufficient to keep the bulk of offerings in good balance. Live supplies were mostly moderate; weights varied, but were generally desirable. Processing schedules were moderately heavy. Less than trucklot asking

prices were 1 cent higher at 66 to 80 cents. Trade sentiment was fully steady to firm. In the parts complex, offerings were adequate to closely cleared. Bone-in breasts were in tightest supply.
