Daily National Grain Market Summary

After two consecutive days of higher prices, grain and soybean bids turned lower. Export sales have slowed somewhat this week but a slight pickup in farmer selling has been reported in places. A decline in soybean meal demand weighed on bean bids. Wheat 3 to 5 cents lower. Corn 1 to 2 cents lower. Sorghum 3 cents lower. Soybeans 1 to 5 cents lower except Minneapolis 1 cent higher. Winter wheat crop continued to concern traders as dry weather conditions remain in the southern Plains. However, recent upturns were seen as over- done and corrections were made on the Board today. Light export sales are all that have been reported, despite the very low prices. Large world stocks continue to increase competition and pressure bids lower. Corn and soybean bids slipped moderately lower also due to light foreign trading and traces of producer selling, however, many are reluctant to sell before the first of the year.
